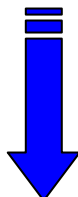

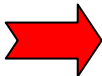

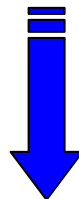
Customer : eligibility : All customers that have graduated no more than 24 months prior to the date of his/her credit application are eligible providing:

- ⇒ They never received a Volkswagen College Graduate rebate before and,
- ⇒ They are not a Volkswagen Canada employee or their relatives.

Applicant Eligibility Requirements : To qualify under the Volkswagen Finance College Graduate Program, the graduate must lease or finance the vehicle as an individual and hold...

a diploma from a Canadian or U.S. University (Bachelor, Master and Doctorate), a Canadian community college of a 2 year study program, or a CEGEP program of 2 or 3 years (DEC). Any graduates from a recognized nursing, military or police school are also eligible.

- The customer must either be permanently employed or provide a verifiable commitment for employment.
- The customer may NOT have any derogatory credit.
- The customer must provide 1 personal reference, which can be contacted directly.
- The customer must be leasing or financing a vehicle for which the proposed monthly payment will not exceed 25% of the applicant's gross monthly income.
- The finance or lease contract must be registered under the student's name as a buyer/lessee or co-buyer/co-lessee. Guarantor are not eligible.

Requirements:

Credit : All customers are subject to credit approval.

Funding Requirements:

- **Leasing :** On a Lease contract you must show the rebate on the appropriate line without taxes.
- **Retail, Driver's Option :** On a Retail contract you must specify the Graduate rebate portion under down payment (other) and is taxes included. Driver's option is not available in Quebec
- **Rates, Money Factors, Residual Values :** As per current published bulletins.

Additional information:

1. **Sales must be reported in VIM between February 3rd 2009 and January 4th 2010 without exception.**
2. Credit applications must be submitted before the end of business day on **January 4th 2010.** Contract date **must be the same as the delivery date.**
3. Volkswagen Finance must receive the funding packages with the completed rebate form no later than January 15th, 2010. All contracts are subject to verification and validation through the reporting system.
4. **Ineligible vehicles:** Fleet vehicles, used vehicles and service loaners reported sold in the Volkswagen Canada VIM system.
5. Demos with less than 10,000 kms are eligible.
6. **No exception will be processed.**
7. **Audits:** Volkswagen Canada and/or Volkswagen Finance have the right to audit a Dealer and to disqualify a transaction if it is not eligible under the terms of this program. The dealership will be charged back the cost of the rebate plus **10%** administration fee for any transaction found to be ineligible. By participating in this program, the dealer agrees to pay these charges promptly.
