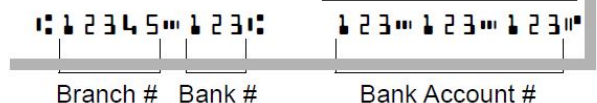
We acknowledge and agree to a second presentation in the case of payments not honoured by our financial institution.
